Subscription by ThomasLloyd CTI Asia Holdings Pte Ltd. to shares in Negros Island Solar Power Inc.

Background/Description of the Disclosure

Negros Island Solar Power Inc. ("ISLASOL"), a subsidiary of the Company, signed with ThomasLloyd CTI Asia Holdings Pte Ltd. ("ThomasLloyd") a subscription agreement for 33,691 Redeemable Preferred Shares E in ISLASOL (the "Shares") at a subscription price of Php 2,780,224,857.21, to be issued out of the increase in ISLASOL's authorized capital stock. ISLASOL owns and operates an 80 MW solar farm in La Carlota and Manapla, Negros Occidental. The Company currently wholly owns and controls ISLASOL through its subsidiaries GigaAce 3, Inc. ("GigaAce 3") and Visayas Renewables Corporation ("VRC"). As previously disclosed in Reference No. C02246-2020, GigaAce 3 acquired ownership in ISLASOL from the PINAI Investors on March 23, 2020. On the other hand, VRC is part of the assets that were transferred by AC Energy, Inc. to the Company pursuant to property-for-share swap in 2019 that is currently undergoing regulatory approvals.

Following the issuance of the Shares and a programmed partial redemption of GigaAce 3's ISLASOL shares, ThomasLloyd's and the Company's (through GigaAce 3 and VRC) ownership interests in ISLASOL will be at 34% and 66%, respectively.
